- I understand that Animal House cannot guarantee the adopted animal's breed, age or history.
- I agree to register the adopted pet's microchip with the appropriate microchip registry at time of adoption. _____ charges a registration fee of _____ payable at time of adoption.
- I agree to keep a current identification tag attached to a properly fitted collar on the animal at all times, and to obtain the required licensing from local authorities.
- I agree to not allow the adopted animal to roam at large.
- I agree to provide the adopted animal with proper shelter, food, and water.
- I agree that this animal will primarily be an indoor pet and will not be kept in an outside run/pen or any fenced area unsupervised. Our intent is that this animal is a part of the family and not be emotionally or physically neglected.
- I agree to provide the adopted animal with proper veterinary care including vaccinations and heartworm prevention as advised by my veterinarian. I acknowledge that I am receiving a copy of the rabies education brochure and all treatment records of the adopted animal.
- I agree to not physically alter the adopted animal in any permanent manner such as ear cropping or tail docking.
- I agree not to abuse and/or neglect the adopted animal. It is Animal House's discretion to determine if the adopted animal has been abused and/or neglected. If abuse and/or neglect is found, Animal House has the right to take possession of the animal immediately.
- I understand that the adopted animal is in good health as far as can be determined by AH and that AH is not responsible for any medical fees incurred after the adoption date. AH is an animal shelter and like all other humane societies and animal shelters/rescue, Animal House does not provide post adoption medical care. To help with potential, unforeseen medical expenses, Animal highly encourages adopter to enroll for 30 days of free insurance through 24PetWatch or Trupanion. It is not required, but encouraged for your protection against unforeseen medical expenses. I understand that if I do sign up for this insurance, it is my right to cancel or choose continued enrollment after the initial 30 days of coverage.
- I understand that Animal House does not guarantee the temperament of the adopted animal. Animal House will be happy to refer me to an animal behaviorist to answer any questions.
- If for any reason, I can no longer care appropriately for the animal, I agree to notify Animal House to discuss the matter. If it is decided to be in the best interest of the animal, I will immediately release it into Animal House's care.
- I agree to give Animal House visitation rights to ensure that the terms of this adoption contract are being met.
- I agree that any failure in the aforementioned items constitutes a breach of contract. In the event of any such breach, I authorize Animal House to reclaim immediate possession and ownership of the adopted animal and no monies will be returned.
- If this contract is breached or I choose to return the adopted animal to Animal House, I agree to pay all associated costs of returning the adopted animal to Animal House.
- I agree to notify Animal House of any telephone number and address changes within 30 days of such a change.
